 ORDINANCE TO ESTABLISH SALARY AND COMPENSATION
 FOR EMPLOYEES AND ELECTED OFFICIALS

WHEREAS, IC 36-5-3-2 states that town legislative body shall fix the compensation of its own members, the town clerk-treasurer, the town superintendent, town marshal and other town officials and employees.

WHEREAS, the Town Council wishes to establish the salaries that shall be effective January 1, 2025

Therefore, be it ordained by the Town Council that the following salary schedule shall be in force and effective January 1, 2025
